**Mr Phil Hogan** 

European Commissioner for Agriculture and Rural Development

Phil Hogan has occupied various senior posts at local, national and European level before becoming the European Commissioner for Agriculture and Rural Development in 2014. This includes the Presidency of the Council of EU Environment Ministers (2013), Chairman of the European People's Party of Environment Ministers (2012-14), National Director of Elections for the Fine Gael party (2010-11), Fine Gael Director of Organisation (2002-2007), Chairman of Kilkenny County Council (1985 and 1998), Chairman of the Fine Gael Parliamentary Group (1995-2001) and Minister of State at the Irish Department of Finance (1994-1995).

As European Commissioner for Agriculture and Rural Development, Phil Hogan oversees EU agricultural and rural development policies for promoting growth, investment and new jobs and the effectiveness of EU spending on agriculture and rural development.



Ms Catherine Geslain-Lanéelle

Director-General for the Economic and Environmental Performance of Enterprises, French Ministry for Agriculture Catherine Geslain-Lanéelle is an engineer and a high official of the French Ministry for Agriculture, currently holding the position of the Director-General for the Economic and Environmental Performance of Enterprises (performance économique et environnementale des entreprises, DGPE). Catherine Geslain-Lanéelle has been Executive Director of the European Food Safety Authority (EFSA) between 2006 and 2013. Prior to this, she held high positions on national and regional level related to the agriculture and food sectors.

Catherine Geslain-Lanéelle holds an engineering degree from the Ecole Nationale du Génie Rural des Eaux et Forêts (ENGREF) and from the Institut National Agronomique Paris-Grignon (Ina-PG). She holds also a degree in Community Law from Paris II.

Ms Carole Delga

President, Occitanie region, France

Carole Delga was elected President of the Occitanie / Pyrénées-Méditerranée Region in January 2016. Previously, she was appointed Secretary of State for Trade, Crafts, Consumer Affairs and Social and Solidarity Economy in 2014 in the first government of Manuel Valls. In 2012, she was elected to the French National Assembly where she was member of the Finance Committee and Special Observer of the National Education and Agricultural Training Budget. From 2010 to 2012, Carole Delga was Vice-President of Regional Council of the Midi-Pyrénées Region in charge of Rural Affairs, Public Services and Information and Communication Technology. Moreover, Carole Delga served as Mayor of Martres-Tolosane for two terms from 2008 to 2014.

Carole Delga graduated from the University of Pau and the University of Social Science Toulouse 1. After university, she joined the public service, working for the City of Limoges. In 1998, she became Chief Executive Officer of the Water Board, Barousse, Comminges-Save, and in 2005, Deputy Director of Town and Country Planning of the Midi-Pyrénées Region.



Mr Pim van Ballekom

Vice-President, European Investment Bank

Pim van Ballekom was appointed Vice President of the EIB in January 2012. His responsibilities include transport and transport infrastructure including TEN-T, financing of natural resources and agribusiness / bio-economy, financing operations in the BENELUX, Turkey and ACP-OCT policies and financing operations in ACP countries and OCTs (except West Africa and the Pacific) and the Republic of South Africa. He is also Governor of the European Bank for Reconstruction and Development.

Pim Van Ballekom has held many roles including Head of Cabinet of European Commissioner Bolkestein responsible for Internal Market, Taxation and Customs Union Head, Netherlands Director at the European Bank for Reconstruction and Development, head of International Public Affairs at APG Pension Group, Financial Counsellor and Head of the Financial Section at the Permanent Representation of the Netherlands at the EU, and various positions within the Ministry of Finance in the Netherlands.
